

THRESHOLD INCOME

1

Calculate taxable Income (include all earnings and investment income)

2

Deduct gross member contributions paid (whether under the relief at source method or net pay arrangement)

3

Add any employment income given through a salary exchange agreement set up after 08/07/15

4

Deduct any taxed lump sum death benefits received
